



EPB SECOND SPACE NIGHT SHIFT RATE PLAN — SCHEDULE TSRS

Effective October 2024

AVAILABILITY

This rate shall apply only to electric service to an appurtenance of a single-family dwelling served under EPB's Residential Rate—Schedule RS, where such appurtenance is separately metered and where the major use of electricity is for domestic purposes such as, but not limited to, pool pumps and houses, garages, barns, sheds, household appliances, and the personal comfort and convenience of those residing in said single family dwelling. This rate is not available to accounts with (1) demand over 50 kW, (2) monthly usage over 15,000 kWh, or (3) power needs requiring three-phase service.

CHARACTER OF SERVICE

Alternating current, single-phase, 60 hertz. Power shall be delivered at a service voltage available in the vicinity or agreed to by EPB.

BASE CHARGES

Customer Charge: \$16.55 per month

Energy Charge: 11.911¢ per kWh per month for all on-peak kWh, plus
7.701¢ per kWh per month for all off-peak kWh

ADJUSTMENT

The base customer charges and energy charges shall be increased or decreased in accordance with the current Adjustment Addendum published by TVA.

DETERMINATION OF ON-PEAK AND OFF-PEAK HOURS

The on-peak hours for each day shall be from 5 a.m. to 11 p.m. The off-peak hours for each day shall be from 11 p.m. to 5 a.m. Such times shall be Eastern Standard Time or Eastern Daylight Time, whichever is then in effect. Said on-peak and off-peak hours are subject to change by EPB. In the event EPB determines that such changed on-peak and off-peak hours are appropriate, it shall so notify TVA at least 2 months prior to the effective date of such changed hours, and EPB shall promptly notify customer.

DETERMINATION OF ON-PEAK AND OFF-PEAK ENERGY AMOUNTS

The on-peak and off-peak kWh for any month shall be the energy amounts taken during the respective hours of the month designated under this rate schedule as on-peak and off-peak hours.



MINIMUM MONTHLY BILL

The base customer charge, as adjusted, constitutes the minimum monthly bill for all customers served under this rate schedule except those customers for which a higher minimum monthly bill is required under EPB's standard policy because of special circumstances affecting EPB's cost of rendering service.

PAYMENT

Bills under this rate schedule will be rendered monthly. Any amount of the bill that is unpaid after the due date specified on bill may be subject to additional charges under EPB's standard policy.

CONTRACT REQUIREMENT

Customers choosing service under this schedule shall not be eligible to elect service under any other residential rate schedule earlier than one year after beginning service under this schedule. However, there is no durational term resulting in a minimum bill when a customer terminates service under this rate schedule.

SINGLE POINT DELIVERY

The charges under this rate schedule are based upon the supply of service through a single delivery and metering point, and at a single voltage.

Service is subject to Rules and Regulations of EPB.
